THE 2015 ANNUAL MEETING AND INVESTITURE

The program will feature speakers at both plenary sessions. The orientation speaker for investees on Saturday morning will be Sir Patrick Powers, KGCHS, Vice Governor General for North America. He will give an overview of the development of the Order and the Order's role in the modern world. On Sunday morning Sir Patrick will return to speak to the entire assembly with a report from the Grand Magisterium. Our keynote speaker for Sunday morning will be Monsignor John Kozar, President of the Catholic Near East Welfare Association. He is a frequent visitor to the Holy Land, and will speak on the current situation for Christians in that part of the world, particularly in light of ISIS. Lieutenant Garrity has heard him speak and described his presentation as enlightening and inspiring. At the Sunday session Duke and Becky Stern will speak about the Legacy program and we will honor major contributors to the that program. Also, at one of the two plenary sessions Pierre and Roz Allemond will speak about our Lieutenancy's pilgrimage program. All members are encouraged to attend both sessions.

The Jesuit Church of the Immaculate Conception



Masses for the 2015 Annual Meeting and Investiture will be celebrated at the historic Church of the Immaculate Conception (the “Jesuit:” Church) directly across from the Baronne Street entrance to the Roosevelt Hotel.

The original church on this site was built by French Jesuits who came to New Orleans in the 1830s. The first Mass in the new church was celebrated on August 15, 1857. The lot on which the church was built was a water-covered cypress swamp. It had to be drained inch-by-inch, foot-by-foot. As the city grew around the church, the location eventually became a part of the central business district.

The church lasted for 71 years but eventually construction of nearby office buildings took its toll on the old structure which was deemed structurally unsafe. The old building withstood the pile driving of the adjacent Pere Marquette Building as well as the extra 500 piles for the garage behind the church. However, the blasting of dynamite half a block away for the Canal Bank Building finally rendered the church useless. The church had to be taken down brick by brick. Demolition was completed in September 1928 and new construction began the following month.

The cornerstone of the new church was laid on May 16, 1929. The altar was replaced, the organ reconstructed and the pews put back in position by February 17, 1930. Mass was said at the new Immaculate Conception Church and a solemn dedication took place on March 2, 1930.

UPCOMING HOLY LAND PILGRIMAGE February 17-27, 2016

The Equestrian Order of The Holy Sepulchre of Jerusalem, Southeastern Lieutenancy, is offering a pilgrimage to the Holy Land for the period of February 17-27, 2016. The trip departs Newark, non-stop to Tel Aviv, and includes first class hotels, private motor coach transportation, breakfast and dinner, and all fees and taxes. Upon arrival in Tel Aviv, we will be met by Fr. Peter Vasko, O.F.M., and President of the Franciscan Foundation for the Holy Land who will be our spiritual leader throughout the trip. Fr. Peter has lived in Jerusalem for almost 30 years and is internationally known for his work in the Holy Land. Cost for the pilgrimage is \$3,471 per person, double occupancy. **NOTE: One need not be a member of the Order to participate in these pilgrimages.**

NORTH AMERICAN LIEUTENANTS MEET

The Annual meeting of the North American Lieutenants was held the first week of June in Quebec City, Canada. In addition to lieutenants from the United States and Canada, the meeting was attended by our Grand Master, His Eminence Edwin Cardinal O'Brien, the Governor General Count Agostino Borromeo, and the three Grand Magisterium members from North America. Also participating in the meeting were Monsignor Robert Stern, a member of the Order's Constitution Commission, and Monsignor John Kozar, Executive Secretary of the Catholic Near East Welfare Association (CNEWA). The presider for the meeting was His Excellency Sir Patrick Powers, Vice-Governor General for North America.

The gathering opened on Thursday evening with a vesper and prayer service in the historic Basilica of Notre Dame de Quebec. Presiders for this service were Cardinal O'Brien and His Eminence Gerald Cardinal Lacroix, Archbishop of Quebec. After the service, Cardinal Lacroix hosted a reception for attendees at his residence.

At the opening business session on Friday morning the Governor General gave a report on the state of the Order. At present membership in the Order consists of some 30,000 Knights and Dames throughout the world. Thanks to the contributions of these members, the Order has been able to continue our support for numerous projects in the Holy Land, and has been able to respond to special requests from the Latin Patriarch. Sir Patrick presented a session on the finances of the Order. The Order is committed to increasing transparency in



financial matters and as a result, regular financial reports will be issued to all lieutenancies. Monsignor Kozar presented a report on the status of Christians in the Holy Land, particularly in light of gains made by ISIS in the area. While the number of native Christians in this area has decreased, some 100,000 migrant workers are now employed in Israel, Jordan, and the West Bank. The vast majority of these workers are Catholic and caring for both their spiritual and material needs has placed an increasing burden on the Church in the area. The session concluded with an extensive report from Sir Tom McKiernan, president of the Holy Land Commission, regarding building projects supported by the Order. The afternoon session was devoted to an open forum at which lieutenants could discuss matters of concern in carrying out their mandates.

Saturday morning was devoted to a number current issues. A report was given on the status of the Columbus Hotel in Rome. Italian courts have supported the Order's case for terminating the current operator who has failed to perform satisfactorily. However, while the courts have ruled in the Order's favor, intricacies of Italian law mean that it will be at least another year before the operator will be removed. A lengthy discussion regarding Madaba University in Jordan followed. The Order advanced (loaned) a considerable sum of money for construction of a library, but as yet the library has not been built. The meeting concluded on Saturday evening with a farewell dinner in the historic Chateau Frontenac Hotel. The 2016 lieutenants' meeting will be held in June in Baltimore.




They will be reworked, saving the EOHSJ money that can be sent to support Christians in the Holy Land. Every little bit goes a long way in showing your support.

CLOTHING EMBROIDERED WITH THE JERUSALEM CROSS

To see the many clothing items available, go to www.landsend.com. At the bottom of the home page, click on "Business Outfitters." At the top of the Business Outfitters page, make your selection by category. Or, you can order a catalog at (800) 338-2000. Remember, however, that only the items offered by the Business Outfitters Department can be embroidered with the Jerusalem Cross, not items in the general catalog although some may be identical. There is an embroidery fee.

When you place your order, you will need the Jerusalem Cross Registration Number which is 0353544. (Have the representative verify that this is the Jerusalem Cross.) You will also need a Customer Number which will be assigned to you when you place your first order and, in the future, will identify you with the Jerusalem Cross. If you forget your Customer Number after your first order you can also be located by your name and zip code.

The Jerusalem Cross from Lands' End is only to be used by members of the Order and the Registration Number must not be given to non-members. The Southeastern Lieutenancy receives no benefit from the registration of the Jerusalem Cross or from any embroidered clothing. This information is provided only to let you know of another way to display the Jerusalem Cross.
